## .case FAQs

**Q:** Who is eligible to register a **.case** domain?

**A:** There are no eligibility requirements. **.case** is an open and unrestricted TLD.

**Q:** How can I sign the RRA?

**A:** You can e-sign the RRA the standard way through the CentralNic Registrar Console. From the main dashboard, please click through to 'New TLD RRAs Now Online' to view the available TLD to onboard for.

**Q:** When can I register a **.case** domain?

**A:** **Sunrise Phase:**  
5 JUNE 2023 @ 15:00 UTC  
5 JULY 2023 @ 14:59 UTC  
Start Date allocation for 30 days

**Legal Community Phase:**  
5 JULY 2023 @ 15:00 UTC  
4 AUGUST 2023 @ 14:59 UTC  
Start Date allocation for 30 days

**General Availability:**  
4 AUGUST 2023 @ 15:00 UTC

**Note:** Trademark Claims period will run 90 days from 5 JULY 2023.

**Q:** How much will a **.case** domain cost?

**A:** \$2,000 per year.

**Q:** Does this require special EPP extensions?

**A:** Registrars are required to utilize the Launch Extension to manage the release of new domains during Sunrise and Legal Community, and the Trademark Claims period for gTLDs. More detailed information can be found in the Operations Manual in the CentralNic Registrar Console.

**Q:** When is **.case** available in the OT&E for testing?

**A:** **.case** will be available in our OT&E for testing at least one month prior to the launch of the Sunrise phase.

**Q:** Will **.case** show up in my standard CentralNic registrar account?

**A:** Yes, **.case** will operate through your standard CentralNic registrar account and billing items will appear on your consolidated monthly invoice.
